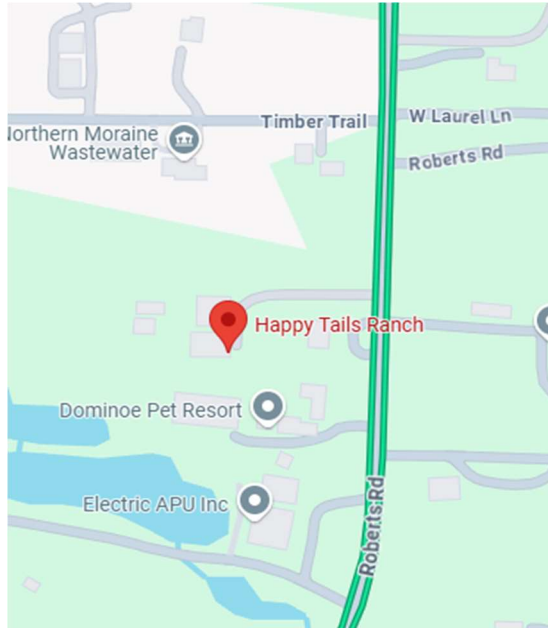

**Dogs Eligible to Enter**

These trials are open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number or are approved Foundation Stock Service (FSS) breeds. Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind or deaf, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate. Wherever the word "dog" is used in these regulations, it includes both sexes.

## Additional Notice to Exhibitors

No smoking is permitted in the building.

RETURNED CHECKS does not constitute a valid entry fee.

ENTRY FEE shall not be refunded if a dog is absent, disqualified, excused by the veterinarian or judge or barred from competition by action of the Show Committee.

BITCHES IN SEASON Any bitch that comes into season after the closing date may have their entry fee returned, less \$5.00 per entry administrative fee without any veterinarian documentation. Any dog injured after closing date may have entry fee

returned, less \$5.00 per entry by providing the trial secretary with a signed statement from a veterinarian at least 1/2 hour before judging begins.

NO ENTRY FEES will be returned if show cannot open or be completed by reasons of riots, civil disturbances, fire, act of God, public emergencies, act of public enemy, strikes, or any other causes beyond the control of the organizing committee

ERRORS ON ENTRY BLANKS Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. There will be no refund for duplicated entries. We will make every effort to find all duplicate entries but if the entry has been processed, no refund will be made.

ENTRIES Must Be Made on Official AMERICAN KENNEL CLUB ENTRY FORMS. With the agreement printed on the reverse side, signed at the bottom by the owner or the owner's duly authorized agent, otherwise entry cannot be accepted.
